

ORDINANCE NO. 2014

AN ORDINANCE AMENDING A PORTION OF ORDINANCE NO. 1994, WHICH ESTABLISHED THE CITY OF DANVILLE, KENTUCKY, ANNUAL BUDGET FOR THE FISCAL YEAR 7-1-2022 THROUGH 6-30-2023 BY APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT.

WHEREAS, the Board of Commissioners adopted an annual budget for the fiscal year 7/1/22 – 6/30/23 in Ordinance No. 1994; and

WHEREAS, the Board of Commissioners has reviewed such budget and deems it necessary to amend the budget as described below;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF DANVILLE, as follows:

SECTION ONE: Section 1 of City of Danville Ordinance No. 1994, establishing the annual budget for the fiscal year beginning 7-1-2022 and ending 6-30-2023 is hereby amended as follows:

SECTION TWO: This ordinance is effective upon its publication.

SECTION THREE: If any section, subsection, paragraph, sentence, clause, phrase, or a portion of this ordinance is declared illegal or unconstitutional or otherwise invalid, such declaration shall not affect the remaining portions hereof.


