### 6. CITY MANAGER REPORT:

City Manager Ron Scott addressed the Commission and addressed the need to hold a special called meeting on Friday, November 2, 2018 at noon in City Hall to approve the purchase of the property for the construction of the new central fire station.

Mr. Scott mentioned that due to Veteran's Day being observed on Monday, November 12<sup>th</sup> the next regular Commission meeting would be held on Tuesday, November 13<sup>th</sup>.

Mr. Scott also reminded the Commission of the special called meeting on Thursday, November 14<sup>th</sup> to discuss the process and procedures other communities use for public art murals.

#### HEAR THE PUBLIC:

Mary Beth Touchstone addressed the Commission to talk about the Science & Play to go exhibit that is at the Boyle County Public Library. She said that the exhibit is on loan from the Kentucky Science Center and has been visited by more than 6,500 people since September. She invited the Commission to stop by and check it out.

Steve Cline addressed the Commission and extended an invitation to the Senior Citizen's Chili Fundraiser that will be held on Wednesday, October 24<sup>th</sup> from 4:00-6:00 p.m. at the Senior Citizen's Center, A Gathering Place. This fundraiser is for cancer awareness.

Jane Brantley addressed the Commission and extended an invitation to Trinity Episcopal Church's Annual soup, salad and sandwich luncheon. The luncheon will be held on Thursday, October 25<sup>th</sup> from 11:00 a.m. to 1:30 p.m. and she said the proceeds will be divided between The Well of Lexington, which is a home for women who have been exposed to sexual exploitation, prostitution and addiction as well as the preservation fund for Trinity Episcopal Church.

#### COMMISSIONER'S COMMENTS:

Commissioner Caudill congratulated Grace Café for their recognition by the Obama Foundation. He said that it was nice to see the café recognized for the work that they do.

After being asked by Mayor Perros, Jacob Pankey addressed the Commission about the Boyle Landmark Trust's 3<sup>rd</sup> Annual Spirit of Preservation event. He said the guest speaker was Eric Rawlings the Staff Architect for the Kentucky Heritage Council. Jacob said the event was held at Chaplin Hill Bed and Breakfast, which is a new Air BNB in Danville. The bed and breakfast is owned by Jay and Holly Wood and he said that they have done something unique with the historic property to help with the heating and cooling of the large home. Jacob said that the couple installed solar panels on a parcel of the land that is out of sight. He said that this presented an educational opportunity for other owners of large historic properties on how to cost effectively heat and cool their large historic homes.

Commissioner Serres said that the Bourbon Chase event was very successful and gave a shout out to CVB, the Heart of Danville, Police Department, Public Works Department, and the City Engineer. He said that the comments from the visitors were all very positive.

Mayor Perros said that the Bourbon Chase was a phenomenal event and a fun night.

#### 7. PAYMENT OF THE BILLS:

Commissioner Terry made a motion to approve the bills as presented in the amount of \$347,610.49. The motion was seconded by Commissioner Serres and unanimously approved upon voice vote of those present.
